January 19, 2023

To all members of the Legislative Committee, there were 45 new bills introduced since the last report. The total number of bills are at 8,854 for this session. There were no new bills added to our tracking lists this week. The total number of our tracked bills stayed the same at 142, with 100 bills in Fire & Emergency Services and 42 bills in Pensions. There are currently eleven bills sitting on The Governor's Desk and he has signed 154 bills to date.

There is Assembly Committee Meetings for today, one of our tracked bills is listed to be heard, A-377 exempts experienced firefighters from certain requirements. There will Assembly Committee meetings for Monday, January 23, 2023, and Senate Committee Meetings for Thursday, January 26, 2023, listed on the schedule. As well as an Assembly Voting Session for Thursday, January 26, 2023, but they have not posted a bill listed for any of these yet as of this report.
