March 16, 2023

To all members of the Legislative Committee, there were 6 new bills introduced since the last report. The total number of bills are at 9,346 for this session. No new bills were added to our tracking lists this week. The total number of our tracked bills stayed the same at 154, with 112 bills in Fire & Emergency Services and 42 bills in Pensions. There are currently nineteen bills sitting on The Governor's Desk and he has signed 178 bills to date.

There are Senate and Assembly Committee meetings set for today and Monday. One of our tracked bills is scheduled to be heard today in the Senate Appropriations Committee Meeting (see attached). The Senate Appropriations Committee Meeting on Tuesday, March 14, 2023, was cancelled and rescheduled to Tuesday, March 21, 2023, to discuss the new FY 2024 State Budget.

I have not set a date for the annual Legislative Meeting, I am still waiting on some meetings with the Sponsors of the Volunteer Cancer Screening Bills. I would like to share the information with everyone from those meetings as soon as they happen. I will keep everyone posted on this.
