Legislative Committee September 22, 2022


To all members of the Legislative Committee, there were 172 new bills introduced since last week. The total number of bills are at 8,232 for this new session. There were no new bills added to our tracking lists as of this report. The total number of our tracked bills stayed the same at 116, with 81 bills in Fire & Emergency Services and 35 bills in Pensions. There are currently four bills sitting on The Governor's Desk and he has signed 117 bills to date.

The Assembly Military and Veterans Affairs Committee meet this morning and heard one of our tracked bills, A-119, which provides for retained eligibility for members of NJ National Guard or reserve component called to active federal military service who met fire department maximum age requirement at closing date of civil service examination. This bill was approved and released by the Committee.

There will be a Senate Voting Session on Thursday, September 29, 2022, at 12:30pm but they have not released the list of bills that will be voted on yet. There will also be Assembly and Senate Committee Meetings, but they have not posted which committee or a bill list as of this report.

I want to thank all members of the Legislative Committee for assisting with the Registration for the Convention, it was much appreciated. The checks will be issued and mailed out to everyone.
