Legislative Committee September 28, 2023

To all members of the Legislative Committee, there have been no new bills introduced since the last report. The total number of bills stayed the same at 10,177 for this session. The total number of our tracked bills stayed the same at 180, with 132 bills in Fire & Emergency Services and 48 bills in Pensions. The Governor did sign three bills into law this past week (see attached). There are currently thirty-eight bills sitting on The Governor's Desk and he has signed 329 bills to date. Two of our bills are currently sitting on The Governor's Desk waiting to be signed (A-5179 &S-861).

There is nothing on the schedule for next month yet. The Assembly and Senate Schedule is both out for November 2023 to January 2024. I am sure it will change several times from now till then but this is the first sign of any activity since the summer. I have attached both current copies of the schedule for both the Assembly and the Senate.
