Legislative Committee November 16, 2023

To all members of the Legislative Committee, there have been no new bills introduced since the last report. The total number of bills stayed the same at 10,177 for this session. The total number of our tracked bills stayed the same at 180, with 132 bills in Fire & Emergency Services and 48 bills in Pensions. There are currently thirty bills sitting on The Governor's Desk and he has signed 337 bills to date.

Two of our tracked bills are currently sitting on the Governor's Desk waiting to be signed. A-5179, "Fire Life Safety Damper and Smoke Control System Inspection Verification Act"; Requires routine maintenance and periodic testing of smoke dampers, fire dampers, and smoke control systems in certain buildings by qualified personnel. S-861, allows municipalities to conduct an annual event for open burning of Christmas trees. We are currently at six of our tracked bills that have been signed into law for this Legislative Session.

There is an Assembly Quorum Call on schedule for Monday, November 20, 2023, with some Assembly Committee Meetings, however, none of our tracked bills are listed to be heard for them. There will be a Senate Quorum Call with Committee Meetings on the Schedule for Monday, November 27, 2023, however, the bill list for these meetings has not been posted yet. There will be both a Senate and an Assembly Quorum Call on Thursday, November 30, 2023, however, the bill list for these meetings has not been posted yet.
