Legislative Committee

April 11, 2024

To all members of the Legislative Committee, the total number of bills introduced is 7,724 already for this session. There were 45 new bills added since the last report. The total number of our tracked bills stayed the same and is at 224, with 119 bills in Fire & Emergency Services, 67 bills in Firemen's Home, and 38 bills in Pensions. There are currently four bills sitting on The Governor's Desk and he has signed seven bills into law.

There are both the Assembly and Senate Committee meetings on the schedule for today, however, none of our tracked bills are listed to be heard. There are also Assembly and Senate Voting Sessions scheduled for Monday, April 8, 2024, there are no list of bills yet for either session. There are still Assembly and Senate Budget Sessions on the list for the rest of the month of April as well. I attached the Senate Schedule for May to June 2024 (this is the first version, there are always changes).

I would like to schedule the annual Legislative Committee Meeting for the first or second week in May. I am looking at one of the nights during the week, however, I just haven't confirmed the date yet. As soon as I confirm it, I will send it out to everyone. Just a reminder it is mandatory for all Legislative Committee Members (it will be held via zoom again this year). If anyone has any issues once the date is set, please don't hesitate to contact me.
