Legislative Committee September 26, 2024

To all members of the Legislative Committee, the total number of bills introduced is 9,125 already for this session. There were 92 new bills added since the last report. The total number of our tracked bills stayed the same at 271, with 149 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 49 bills in Pensions. There are currently no bills sitting on The Governor's Desk waiting to be signed. The Governor signed eighty-one bills into law to date.

On Thursday, September 19, 2024, one of our tracked bills was heard in the Assembly Labor Committee. A-2100, which provides workers' compensation benefits for certain public safety workers who developed illness or injury as result of responding to September 11, 2001 terrorist attacks, was reported out of committee with committee amendments and referred to the Assembly Public Safety and Preparedness Committee. On Monday, September 23, 2024, one of our tracked bills was heard in the Assembly Higher Education Committee. A-3533, which increases tuition credit amount permitted under volunteer tuition credit program, was reported out of committee, and referred to the Assembly Appropriations Committee. There is an Assembly Voting Session and a Senate Quorum on the schedule for today, however, none of our bills are lists to be heard.

I attached the Assembly and Seante Schedules for September to December. I am sure they will change and have some revisions, but this is what is posted so far.
