## **Legislative Committee**

**October 17, 2024**

To all members of the Legislative Committee, the total number of bills introduced is 9,320 already for this session. There were 17 new bills added since the last report. I added two new bills to our tracking lists, S-3806, which exempts volunteer fire companies, emergency service providers, and veteran organizations from charitable registration fees, & S-3812, which removes certain limitations on receipt of retirement or death benefits under PFRS. The total number of our tracked bills is now at 277, with 151 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 53 bills in Pensions. There are currently nine bills sitting on The Governor's Desk waiting to be signed. The Governor signed eighty-three bills into law to date.

There are a bunch of Assembly & Senate Committee Meetings on the schedule for today and Monday, however, none of our tracked bills are listed to be heard. On Thursday, October 24, 2024, there will be an Assembly Quorum but, they have not posted a list of committee hearings yet.
