## Legislative Committee December 5, 2024

To all members of the Legislative Committee, the total number of bills introduced is 9,607 already for this session. There were no new bills added since the last report. The total number of our tracked bills stayed the same at 279, with 155 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 54 bills in Pensions. There are currently twelve bills sitting on The Governor's Desk waiting to be signed. The Governor signed ninety-eight bills into law to date.

There are a bunch of Assembly and Senate Committee meetings on the schedule for today and Monday, however none of our tracked bills are listed to be heard. On Thursday, December 12, 2024, there are both Assembly and Senate Quorum calls, but they haven't posted the list of committees or bills to be heard yet.
