# Legislative Committee December 12, 2024

To all members of the Legislative Committee, the total number of bills introduced is 9,697 already for this session. There were 90 new bills added since the last report. I added six new bills to our tracking lists (see attached). The total number of our tracked bills is now at 288, with 160 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 55 bills in Pensions. There are currently eleven bills sitting on The Governor's Desk waiting to be signed. The Governor signed ninety-nine bills into law to date.

One of our tracked bills is listed to be heard today in the Senate Commerce Committee. S-3098, which requires health insurers to provide coverage for biomarker testing. The Assembly version of this bill (A-4163) is listed to be heard in the Assembly Appropriations Committee on Monday, December 16, 2024.

On Thursday, December 19, 2024, there are both Assembly and Senate Voting Sessions listed on the schedule, but they haven't posted the list of bills to be heard yet.
