January 2, 2025

To all members of the Legislative Committee, the total number of bills introduced is 9,859 already for this session. There were 93 new bills added since the last report. I added two new bills to our tracking lists (see attached). The total number of our tracked bills is now at 290, with 162 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 55 bills in Pensions. There are currently twenty-three bills sitting on The Governor's Desk waiting to be signed. Two of our tracked bills are currently sitting on the Governor's Desk waiting to be signed (see attached). The Governor signed one hundred thirteen bills into law to date.

If any is interested the Governor's last State of the State Address is scheduled for Tuesday, January 14, 2025, at 3:00 pm.

I have attached both the Assembly and the Senate schedules for January to March of 2025. I am sure it will have some changes, but this is what was put out as of today.
