## **Legislative Committee**

**January 23, 2025**

To all members of the Legislative Committee, the total number of bills introduced is 9,928 already for this session. There were 8 new bills added since the last report. The total number of our tracked bills stayed the same at 297, with 166 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 58 bills in Pensions. There are currently twenty-five bills sitting on The Governor's Desk waiting to be signed. Two of our tracked bills are currently sitting on the Governor's Desk waiting to be signed. The Governor signed one hundred fifteen bills into law to date.

There is a bunch of Assembly Committee Meetings today, however none of our tracked bills are listed to be heard. One of our bills is listed to be heard on Monday, January 27, 2025, in the Assembly Public Safety and Preparedness Committee, A-2145, which provides employment protections for paid first responders diagnosed with post-traumatic stress disorder under certain conditions. There is an Assembly and Seante Voting session scheduled for Thursday, January 30, 2025.
