## **Legislative Committee**

**April 17, 2025**

To all members of the Legislative Committee, the total number of bills introduced is 10,636 already for this session. There were 52 new bills added since the last report. I added 2 new bills to our tracking lists (see attached). The total number of our tracked bills is now at 320, with 188 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 59 bills in Pensions. There are currently twenty-four bills sitting on the Governor's Desk waiting to be signed, including one of our tracked bills, A-4163, which requires health insurers to provide coverage for biomarker precision medical testing. The Governor signed one hundred sixty-two bills into law to date. (I included the updated list of our Tracked Bills that have been signed into law by the Governor for this Legislative Session).

I attached the schedule for both the Assembly and Senate for the next two months. There are usually revisions throughout that time both this is what they have listed so far.

The annual Legislative Committee Meeting will be held on Tuesday, April 29, 2025, at 7:00 pm virtually via zoom. If anyone has any major issues with the date, please let me know as attendance is mandatory for all committee members.
