## Legislative Committee May 8, 2025

To all members of the Legislative Committee, the total number of bills introduced is 10,685 already for this session. There were 50 new bills added since the last report. The total number of our tracked bills stayed the same at 320, with 188 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 59 bills in Pensions. There are currently sixteen bills sitting on the Governor's Desk waiting to be signed. The Governor signed one hundred seventy bills into law to date.

There are Assembly Committee Meetings this afternoon with some of our tracked bills listed to be heard (see attached). Senate Quorum is on the schedule for Monday, May 12, 2025, and Assembly Quorum is on the schedule for Thursday, May 15, 2025. They have not posted the list of committees that will meet yet or a list of bills to be heard.

I want to reminder everyone the Bill Voting List is due back to me May 29, 2025. Any questions or issues with this please let me know, if you need me to explain a certain bill a little further, please don't hesitate to contact me. I have received responses from about a third of the committee so far.
