Legislative Committee May 14, 2025

To all members of the Legislative Committee, the total number of bills introduced is 10,837 already for this session. There were 152 new bills added since the last report. I added 3 new bills to our tracking lists, all of them are related bills to ones we are tracking. The total number of our tracked bills is now at 323, with 189 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 61 bills in Pensions. There are currently no bills sitting on the Governor's Desk waiting to be signed. The Governor signed one hundred eighty-one bills into law to date.

Tomorrow there is an Assembly Public Safety and Preparedness Committee on the schedule at 10:00 am. Two of our bills are listed to be heard, A-4005, which requires emergency medical technicians and firefighters to receive training concerning electric vehicle fires & A-5538, which prohibits municipal utilities authority from charging fire district water service charges for fire protection systems if authority imposes water service charges on customers who are also taxpayers of fire district.

There are Senate Quorums on the schedule for Monday, May 19, 2025, and Thursday, May 22, 2025. They have not posted the list of committees that will meet yet or a list of bills to be heard. There is an Assembly Voting Session on the schedule for Thursday, May 22, 2025, however they have not posted a list of bills to be heard yet.

I want to reminder everyone the Bill Voting List is due back to me May 29, 2025. Any questions or issues with this please let me know, if you need me to explain a certain bill a little further, please don't hesitate to contact me. I have received responses from about a third of the committee so far.
