Legislative Committee

May 29, 2025

To all members of the Legislative Committee, the total number of bills introduced is 10,981 already for this session. There were 144 new bills added since the last report. I added 3 new bills to our tracking lists, all of them are related bills to ones we are tracking. The total number of our tracked bills is now at 324, with 190 bills in Fire & Emergency Services, 73 bills in Firemen's Home, and 61 bills in Pensions. There are currently eight bills sitting on the Governor's Desk waiting to be signed. The Governor signed one hundred eighty-two bills into law to date.

There are Senate Committee Meetings on the schedule for today. Three of our tracked bills are listed to be heard in the Senate Law and Public Safety Committee and one of our tracked bills is listed to be heard in the Senate State Government, Wagering, Tourism, and Historic Preservation Committee today (see attached).

Next week there is a Senate Voting Session on the schedule for Monday, June 2, 2025, and a Senate Quorum Call for Thursday, June 5, 2025. They have not put out a list of bills to be voted on for Monday or a list of committees or bills to be heard for Thursday yet.

I want to reminder everyone the Bill Voting List is due back to me today, May 29, 2025. Any questions or issues with this please let me know, if you need me to explain a certain bill a little further, please don't hesitate to contact me. I have received responses from almost everyone at this point and I am only missing a few.
