## **Legislative Committee**

**June 12, 2025**

To all members of the Legislative Committee, the total number of bills introduced is 11,047 already for this session. There were 10 new bills added since the last report, I did not add any new bills to our tracking lists. The total number of our tracked bills stayed the same at 328, with 193 bills in Fire & Emergency Services, 74 bills in Firemen's Home, and 61 bills in Pensions. There are currently fifteen bills sitting on the Governor's Desk waiting to be signed. The Governor signed one hundred eighty-five bills into law to date.

There are a bunch of Assembly and Senate Committee Meetings on the schedule for today. Some of our tracked bills are listed to be heard (see attached).

Next Week there are both Assembly and Senate Committee Meetings on the schedule for both Monday & Thursday. They have not put out a list of bills to be heard as of this report.

I sent the results from the Bill Voting Lists along with an updated Tracking Lists in a progress report to show the updated positions in an email on Tuesday.
