## Legislative Committee Report December 18, 2025

We are in the 2024-2025 Legislative Session, there has been a total of 12,023 bills introduced as of this report. The total of our tracked bills is 335, with 198 bills in Fire & Emergency Services, 61 bills in Pensions, and 76 bills in Firemen's Home. There are currently 11 bills sitting on the Governor's Desk. The Governor has signed 285 bills into law to date. There are bills that you may find interest in as follows for both the Assembly and Senate some of which are duplicates due to revisions being done in committee.
